Key Risks for Discount Retail Private-Label Sourcing

Weak factory quality infrastructure

Most Chinese food & non-food factories lack retailer-aligned quality systems. Poor documentation and cost-driven tolerance of defects are common.

One-off inspection cannot resolve root causes

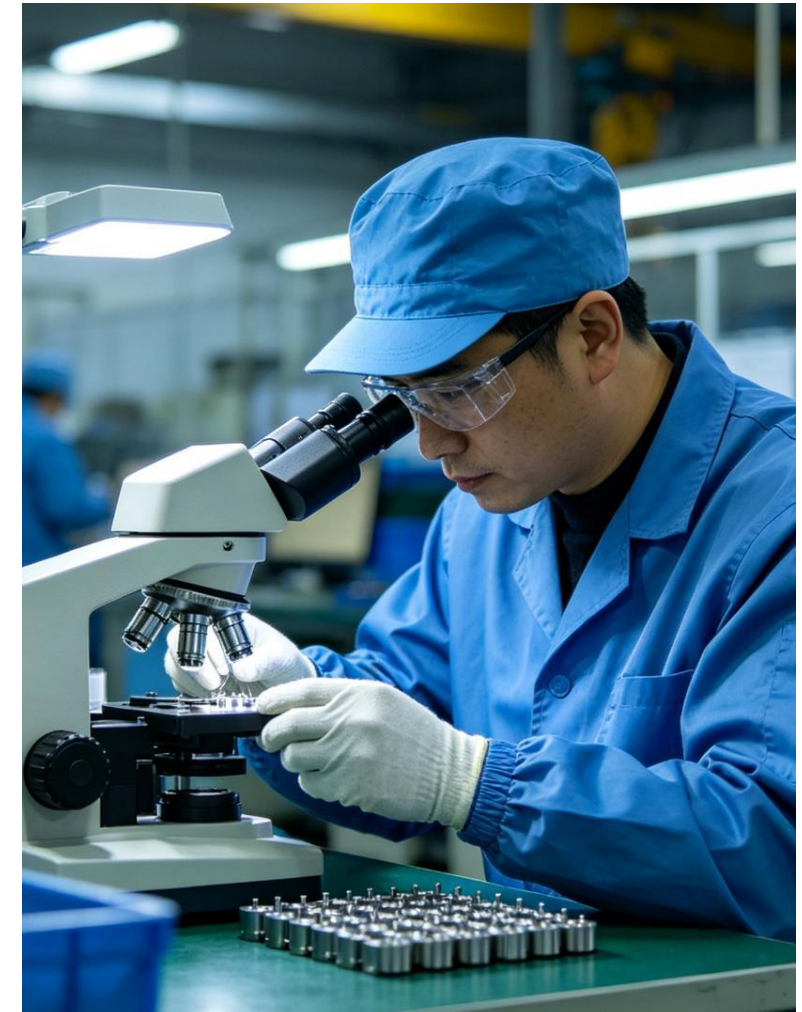
Third-party sampling is transaction-based, without pre-production or in-line monitoring. Collusion risks exist. Late defect discovery triggers rework, delays, extra costs and damages end-consumer trust.

Audits deliver only short-term improvement

Audit reports are issued without follow-up rectification. Factories frequently revert to non-compliance. Hidden risks cover labour, environmental, security and food hygiene.

Private-label brands have zero tolerance for failures
